#### How We Use Cookies:

- Essential cookies Necessary for the website to function.
- Analytics cookies Help us understand how visitors interact with our website (e.g., Google Analytics).
- Advertising cookies Used to deliver relevant ads (e.g., Google Ads, Meta Pixel).

### Meta (Facebook) Pixel

We use the Meta Pixel to measure the effectiveness of our advertising and show you personalized ads on Facebook and Instagram. The pixel tracks your activity on our website and sends it to Meta Platforms, Inc.
